Dear Parents or Guardians:

The Hamilton Township School District is dedicated to providing all students with the educational foundation necessary to succeed in school and in life. The *No Child Left Behind Act* (NCLB) requires that adequate yearly progress (AYP) in language arts literacy and mathematics be measured annually for each school in New Jersey. The Hess Educational Complex and the William Davies Middle School have been identified as "Schools in Need of Improvement" (SINI). As a district being identified with "Schools in Need of Improvement", we are offering supplemental educational services for our students in the form of tutorial services.

Your child has been identified to receive these services based on his/her eligibility to receive free or reduced lunch in the 2011-2012 school year. These tutoring services are funded by Title I of the NCLB Grant and are provided over and above the regular classroom remedial services offered during the school day. Initially, this service is being offered to all students who are economically disadvantaged; however, funds for this service are limited. Therefore, if necessary, we will offer services first and foremost to the students whose academic grades indicate the greatest need.

If you would like to take advantage of this supplemental service, we have scheduled a "Supplemental Educational Services Provider Fair" at the William Davies Middle School in the cafetorium on Wednesday, October 26<sup>th</sup> from 5:30 pm to 7:00 pm. In addition to this, for your information, we have attached a list of the New Jersey Department of Education state approved providers.

For those of you who cannot attend the fair, this does not mean that your child loses eligibility for these services. If you cannot attend the meeting, please complete and return the bottom portion of this letter, as soon as possible, to the Curriculum Office via your child's homeroom teacher. We will be sure to add your child's name to those who would like to be considered for these services.

Please be on the lookout for a brightly colored, follow-up flyer to this letter, reminding you of the date and time of the "Supplemental Educational Services Provider Fair".
