

Through a team that includes faculty and staff from the School of Education, including its Southern Regional Institute and ETTC, and the School of Natural Sciences and Mathematics (NAMS), Stockton University will lead a cohort of teachers from five K-8 school districts in a 2-year project that will explore the instructional shifts required to successfully implement the Next Generation Science Standards (NGSS).

High-quality professional learning opportunities as well as continuous interaction with faculty from the university will support 35 participating teachers from Galloway Twp. Schools, Port Republic School, Hamilton Twp. Schools, Mullica Twp. Schools, and Egg Harbor City Schools as they build their capacity to become effective leaders in their own districts and across the state in both the pedagogy and the science content required for systemic adoption and implementation of the new standards.

Central to this project will be opportunities to strengthen participants' content knowledge within the context of instructional practices. Utilizing the laboratories and classrooms of Stockton's new Unified Science Center and its Nacote Creek Marine Science Field Station, the science faculty will offer a rich program of content-specific sessions to align with participants' needs and the NGSS implementation schedule while faculty from the School of Education will support content with pedagogical strategies that will lead to more effective classroom practices.
